## **Social Outreach Program**


#### Insurance Awareness Rally

Date: 16 December 2024

On the Foundation Day of the National Insurance Academy, students led a high-energy Insurance Awareness Rally to promote the importance of insurance in everyday life. The stretch between Gate No. 1 and Gate No. 2 came alive with slogans, posters, and meaningful conversations with the public.





#### Suraksha Chakra – Sunahari Shubhodhay

Date: 11 to 16 March 2025

In collaboration with: Christ University, Bangalore, and Montfort Senior Secondary School, Konbir.

Suraksha Chakra was more than a field project. It was a six-day immersive experience across seven villages in Jharkhand, where ten students from NIA and Christ University, supported by local ASHA workers, surveyed 955 households to understand the ground reality of financial inclusion.

Under tough weather and challenging conditions, students identified 1,804 uninsured individuals, collected 1,415 consent forms, and flagged 265 residents who lacked basic banking access. The data was submitted to the Block Development Officer of Basia, who acknowledged the depth of work, saying it surpassed typical administrative reports.

The experience combined rural outreach, primary data collection, and real-time outreach. It tested and strengthened our ability to lead, listen, and adapt. Beyond the numbers, it built empathy, purpose, and a deep understanding of how financial literacy can change lives.

This initiative was not just an academic exercise. It was proof that our students are ready to work in complex, real-world environments with professionalism, compassion, and clarity of mission.





## **PGDM Programme**

The two-year full-time Post Graduate Diploma in Management (PGDM) with a specialization in Insurance & Management is approved by AICTE, accredited by NBA, and holds MBA equivalence by AIU. The program blends technical competence in insurance with a strong foundation in management principles and real-world applications. It aims to develop a creative problem-solving approach to meet the evolving needs of today's business environment.

#### **Selection Process**

The selection process begins with shortlisting candidates based on their scores in CAT (Common Admission Test), XAT, or CMAT (Common Management Admission Test). Shortlisted candidates then go through group discussions and personal interviews. To qualify for the Diploma, students must complete six trimesters of academic work, along with an eight-week Summer Internship Program, a Major Research Project, a Value Addition Project, and participation in various workshops.

#### Faculty

NIA's multi-disciplinary faculty consists of academicians and industry professionals. The visiting faculty includes individuals in key industry positions, providing students with real-world insights. Academic excellence is maintained through innovative teaching methods, including interactive discussions, panel discussions, and guest lectures.

#### Culture

As a national institute, NIA fosters a diverse and innovative culture. The institute paves its own path rather than following conventional norms, aspiring to be a benchmark in the insurance and management sector. With a commitment to holistic development, NIA promotes the ideology of "together we grow" in an environment that combines the essence of a traditional Gurukul with modern amenities.

#### **Added Course Benefit**

NIA students who meet the prescribed requirements are eligible for course-wise exemptions from the Insurance Institute of India papers, allowing them to claim up to 220 credit points. This fast-tracks their journey toward becoming Associates and Fellows of the Insurance Institute of India.

#### **Summer Internship Programme (SIP)**

Each student is required to complete an eight-week Summer Internship in a reputed company across different industry verticals. This first-hand industry experience enhances practical learning by bridging the gap between theoretical knowledge and real-world applications. The SIP also plays a crucial role in preparing students for final placements.

#### Major Research Project (MRP)


To cultivate research skills and encourage knowledge generation, students must undertake a Major Research Project (MRP) in the sixth trimester. The project focuses on insurance, management, or allied disciplines, culminating in a detailed research report.

#### Value Addition Project (VAP)

Businesses today seek professionals who can adapt to rapid industry changes and provide innovative solutions. The Value Addition Project (VAP) is designed to enhance problem-solving skills by requiring students to identify a strategically important industry issue and propose practical recommendations to address it.














## **Student Committees**





#### **GENDER RATIO**







